How-to guide: Create an 'Organisation' **Government Gateway ID** for UK-based Art Market Participants

In order to register as an Art Market Participant, you need to have an 'Organisation' Government Gateway ID, which is separate to an individual Government Gateway ID.

It's essential to maintain access to this Organisation account, for example to renew your Art Market Participant registration each year.

Therefore: keep the User ID and password created specifically for this account in a safe place that you will be able to access when needed.

Top security tip: Create a password that is unique to your Organisation Government Gateway ID account. (This means that if your computer gets hacked, it won't be possible for the criminal to easily sign into all of your accounts since they each have unique passwords.)

Step 1: Navigate to the URL for registering or renewing your money laundering supervision with HMRC: https://www.gov.uk/guidance/register-or-renew-your-money-launderingsupervision-with-hmrc

On that page, scroll down the page and click 'Start now' (green box with white text):
